We believe that by following this policy, we can contribute to the responsible management of water resources, protect the environment and ensure the availability of clean and safe water for current and future generations.3.1. Water Efficiency: Strive to reduce water consumption and improve water use efficiency in our operations and operations.3.2. Environmental Responsibility: Minimizing negative impacts on local ecosystems, water bodies, and aquatic life through responsible water use and discharge practices.3.3. Compliance: To ensure compliance with all local, national and international water-related regulations and standards.
