



WILDLIFE MONITORING & WILDLIFE POLICY

1. Tiara Hotel & Spa undertakes to be aware of and fully comply with current local, national and international regulations and guidelines regarding wildlife monitoring and wildlife interactions.

2. Our staff will be trained to ensure wildlife conservation and sustainable interaction in all activities of our hotel. This training will be regularly renewed and updated in collaboration with local nature conservation organizations and experts.

3. Tiara Hotel & Spa is committed to supporting projects that will support efforts to protect and sustain wildlife and natural habitats. These projects can include areas such as habitat restoration, the creation of wildlife sanctuaries, and the sustainable management of local ecosystems.

4. We will provide guests with informative materials on wildlife conservation and respect for the natural environment, and we will inform them of local regulations and guidelines. We will also encourage guests not to disturb or endanger wildlife and not to pollute natural habitats.

5. Tiara Hotel & Spa will take the necessary measures to prevent activities and practices that may disturb wildlife and will act in accordance with local regulations. This includes not interfering with wildlife natural migration routes, nesting sites or feeding areas, and preventing damage to local fauna and flora.

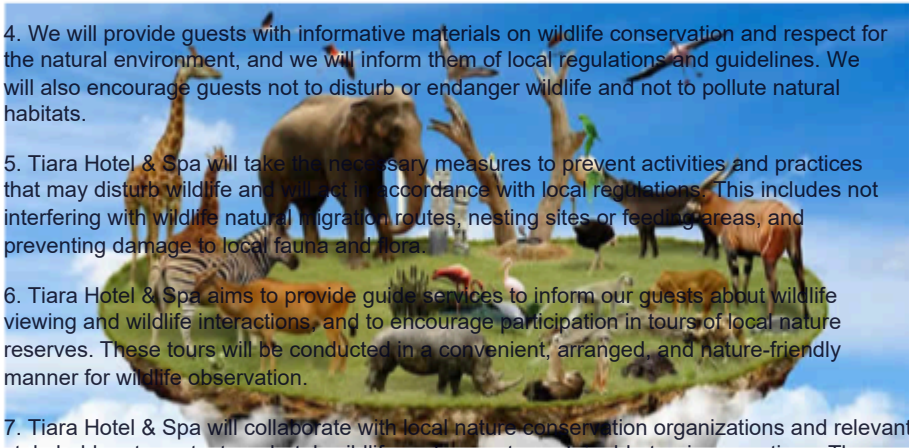

Direct interactions, in particular nurturing, based on the advice of an unaffiliated wildlife expert, are not permitted where they are not specifically endorsed by internationally accepted standards or where standards do not exist. Such interactions can affect wildlife's natural behavior, lead to potential health risks, and disrupt local ecosystem balance. For this reason, we will make sure that direct interactions with wildlife are kept under control in our hotel. This policy reflects our hotel's commitment to wildlife conservation and sustainable tourism practices. All staff and guests are responsible for complying with this policy and are expected to actively contribute to our hotel's wildlife conservation efforts.
